Annual Town Meeting

March 8, 2011

The Annual Town Meeting, held in the Town of Camden in the County of Carver and State of Minnesota, at the Camden Town Hall on the 8th day of March 2011, was called to order at 7:00 P.M. by Roger Sauerbrey, Clerk.

A motion was made by Marvin Meuleners, seconded by Virgil Stender to elect Mike Meuleners as Moderator. Motion carried.

The Moderator, at the opening of the meeting, stated the business to be transacted and the order of the same as listed in the agenda and to transact other business as is by law required or permitted.

The Moderator read the meeting notice that was posted at the Town Hall in New Germany.

The clerk read the minutes of the March 9, 2010 Annual Meeting. A motion was made by Marvin Meuleners and seconded by Stan Werner to approve the Minutes as read. Motion carried.

Discussions were held on the proposed 2012 fire contracts. Representing the Plato Fire Dept. was Ryan Neubarth. The proposed contract with Plato for 2012 is \$1,403.00.

Representing the NYA Fire Dept. was Rob Bauman. The contract with NYA for 2012 is \$15,210.00.

The proposed contract with New Germany for 2012 is \$29,780.72.

The estimated contract with the Mayer Fire Dept. for 2012 is \$10,728.62.

The Clerk presented the 2010 Annual Financial Report for review and any questions were addressed. A motion was made by Virgil Stender, seconded by Alvin Hedtke to accept the report as printed. Motion carried.

Supervisor's Report was presented by David Zellmann on the following: 8,100 yards of gravel were hauled. 3500 yards of gravel were hauled on flood damaged roads and was paid for by FEMA. In 2010 gravel was paid for as it was used. The Board did not have to buy a pile all at one time which resulted in less money being spent in 2010.

Fire Fund: \$59,000.00

A motion was made by Marvin Meuleners, seconded by Bruce Clark to hold the 2012 annual meeting on the 2nd Tuesday in March at 7:00 P.M. at the township shed. Motion carried.

There being no further discussion or business, a motion was made by Alvin Hedtke, seconded by Virgil Stender to adjourn. Motion carried at 7:44 P.M.
