Resolution Number 2018-4 Official Posting of Public Notices. Motion by Zellmann, seconded by Goede. Motion carried.


Resolution Number 2018-5 Adopt Minn. Townships General Records Retention Schedule. Motion by Zellmann, seconded by Devine. Motion carried.
