

**Camden Township Regular Meeting**

**February 18, 2021**

The Town Board of the Town of Camden, Carver County, Minnesota met at the Camden Town Hall, February 18, 2021 at 7:30 pm. Members present were Clerk Lisa Goede, Treasurer Denise Zellmann, Supervisors Gerry Goede, David Zellmann, Bill Devine, maintenance worker Jeff Caswell. Also, in attendance Carver county commissioner John Fahey. The meeting was called to order by Chairman Bill Devine.

A motion made by Zellmann, seconded by Goede to approve the organizational, regular, audit & budget meeting minutes. Motion carried. A motion made by Zellmann, seconded by Devine to approve the payroll, and claims for payment of \$12,826.63. See attached list. Goede abstained due to a conflict of interest, being paid for maintenance work. Motion carried. A motion made by Zellmann, seconded by Devine stating that the Clerk and Treasurer's books balance with the bank statement. Motion carried.

**Clerk's Report:** Shared Carver County building permits; annual meeting postcards will be sent out to residents the week of February 22<sup>nd</sup>.

**Supervisors Report:** Chair Devine reported Plato fire dept. is planning on purchasing a used tanker truck in 2022 at a cost of \$267,877 with a cap of \$271,000. The cost to township will be \$4,000. Supervisor Goede reported NYA fire dept. plans a new tanker in 2024 & 2027 and 2 sets of turnout gear for each fire firefighter and \$1.00/hr. raise.

**Discussion Included:**

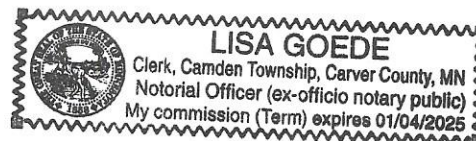
1. Commissioner John Fahey gave a hwy. 212 update. Work will start from Carver to Cologne. The cost for this 4.5-mile stretch is \$50 million. He also stated New Germany city is thankful for the pagers the township purchased with CARES funds.
2. 27 certified letters were sent to residents regarding snowplowing on roadway. Feedback from residents is being addressed as it arises.
3. The IUP issued to Valley Paving was discussed. Commissioner Fahey offered to check with county officials to look into to make sure they are staying in compliance.
4. Stray dogs in the township and whose responsibility for taking care of was addressed to Commissioner Fahey. He will look into.
5. Three groups are interested in doing the spring ditch cleanup. St. John's youth group, Zion Youth group, and Zion church group, who have all done this in the past. Paperwork/maps will be distributed to these groups.
6. Pagers distribution as follows: 10 each to New Germany, Mayer & NYA fire depts; 4 to Plato.

**Road & Equipment Report:** Curt Kubasch contacted the township for doing our dust control, said the whole township could be done in a day or two with his 12 tankers. Jeff noted he tore some sod up snowplowing on McPadden hill.

**Public Comments:** None.

A motion made by Goede, seconded by Zellmann to adjourn at 8:35pm. Motion carried.
