

Annual Town Meeting

March 9, 2010

The Annual Town Meeting, held in the Town of Camden in the County of Carver and State of Minnesota, at the Camden Town Hall on the 9th day of March 2010, was called to order at 7:05 P.M. by Roger Sauerbrey, Clerk.

A motion was made by Gerald Roepke, seconded by David Zellmann to elect Virgil Stender as Moderator. Motion carried. The Moderator, at the opening of the meeting, stated the business to be transacted and the order of the same as listed in the agenda and to transact other business as is by law required or permitted.

The Clerk read the meeting notice that was published in the Waconia Patriot, NYA Times and the Herald Journal.

The clerk read the minutes of the March 10, 2009 Annual Meeting. A motion was made by Stan Werner and seconded by Ryan Neubarth to approve the Minutes as read. Motion carried.

Discussions were held on the proposed 2010 fire contracts. Representing the Plato Fire Dept. was Ryan Neubarth. The proposed contract with Plato for 2011 is \$1,567.70.

Representing the NYA Fire Dept. was Pete Luskey. The contract with NYA for 2011 is \$14,625.00.

The proposed contract with New Germany for 2011 is \$29,780.72.

The estimated contract with the Mayer Fire Dept. for 2011 is \$17,000.00.

The Clerk presented the 2009 Annual Financial Report for review and any questions were addressed. A motion was made by Mike Meuleners and seconded by Marvin Meuleners to accept the report as printed. Motion carried.

Supervisor's Report was presented by Bruce Clark on the following: 7,000 yards of gravel were hauled. Ditch Repair was completed on 92nd Street, west of State HWY 25.

Guests: County Commissioner Jim Ische brought greetings and answered questions. County Deputy Sherriff, Jim Olson greeted us and announced he is going to run for the Sherriff's position in 2010. Sherriff Bud Olson is not running.

The proposed sums of money to be raised by tax upon the taxable property in said town for the following purpose:

General Fund: \$70,000.00

Road & Bridge Fund: \$230,000.00

Fire Fund: \$59,000.00

A motion was made by Tim Zellmann, seconded by Tim Biros to delete the \$10,000.00 County Policing line from the General Fund levy. Motion carried.

A motion was made by Mike Meuleners, seconded by Marvin Meuleners to change the Road & Bridge Fund levy to \$200,000.00. Motion failed.

A motion was made by Gerald Roepke, seconded by Alvin Hedtke to approve the amended proposed levy which is:

General Fund - \$60,000.00

Road & Bridge Fund - \$230,000.00

Fire Fund - \$59,000.00

Motion carried.

A recommendation for legal notices was for the Waconia Patriot, NYA Times and the Herald Journal. The Township is working on getting a web site set up.

A motion was made by Mike Mueleners and seconded by Bruce Clark to hold the 2011 annual meeting on the 2nd Tuesday in March at 7:30 P.M. at the township shed. Motion carried.

There being no further discussion or business, a motion was made by Stan Werner and seconded by Mike Meuleners to adjourn. Motion carried at 9:06 P.M.
